### 1 Our Proposals

The work necessary to meet the requirements of your proposed scheme.

Subject to wayleaves, replace our existing High Voltage (HV) overhead main line crossing to the rear of Sessay Village Hall and the Cricket Grounds with an underground HV cable.

Subject to wayleaves, replace 2 x spans of the existing HV overhead tee to 'Sessay South' pole mounted substation with an underground HV cable.

Please be aware that I cannot rule out that we would need to establish a new ground mounted substation on the site to replace 'Sessay South' pole mounted substation.

From the time accurate costs are produced, we require a minimum of 12 months' notice of the date on which we would be required to start work on site.
